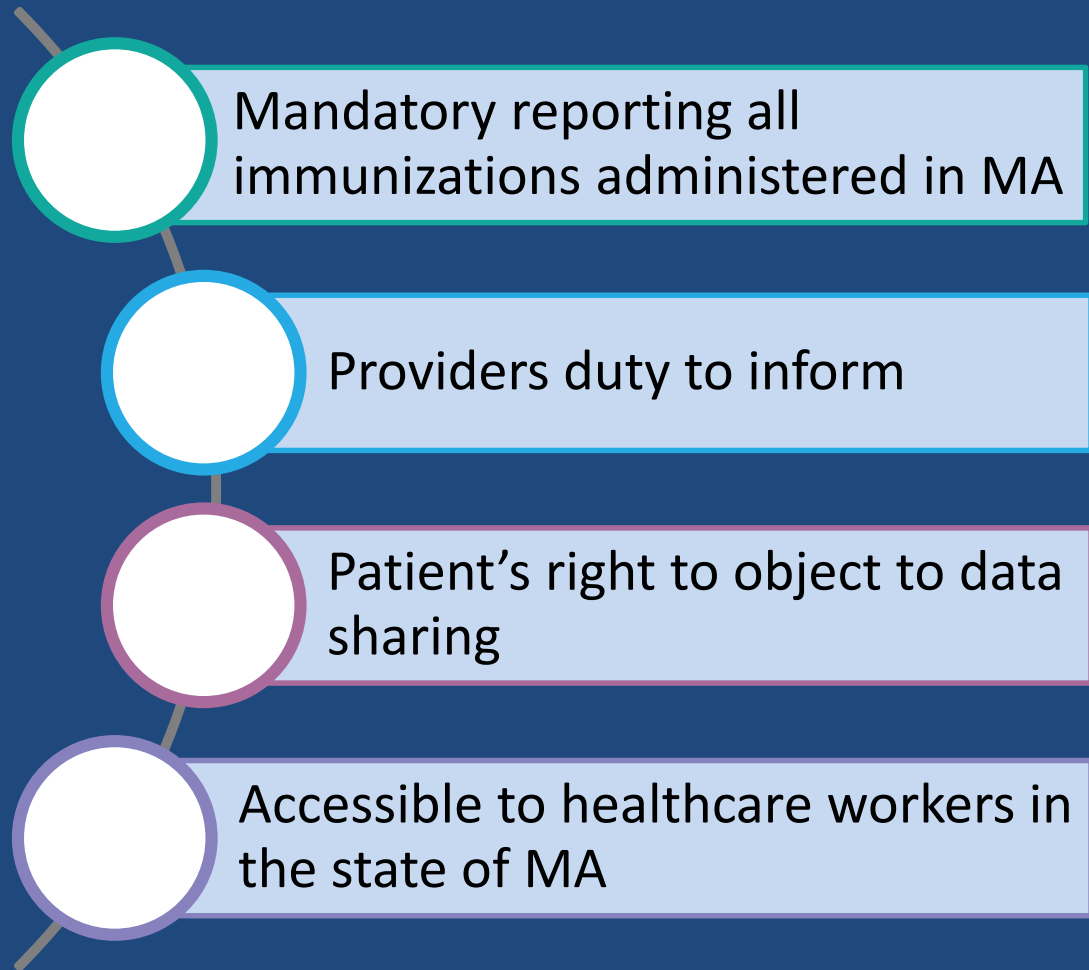

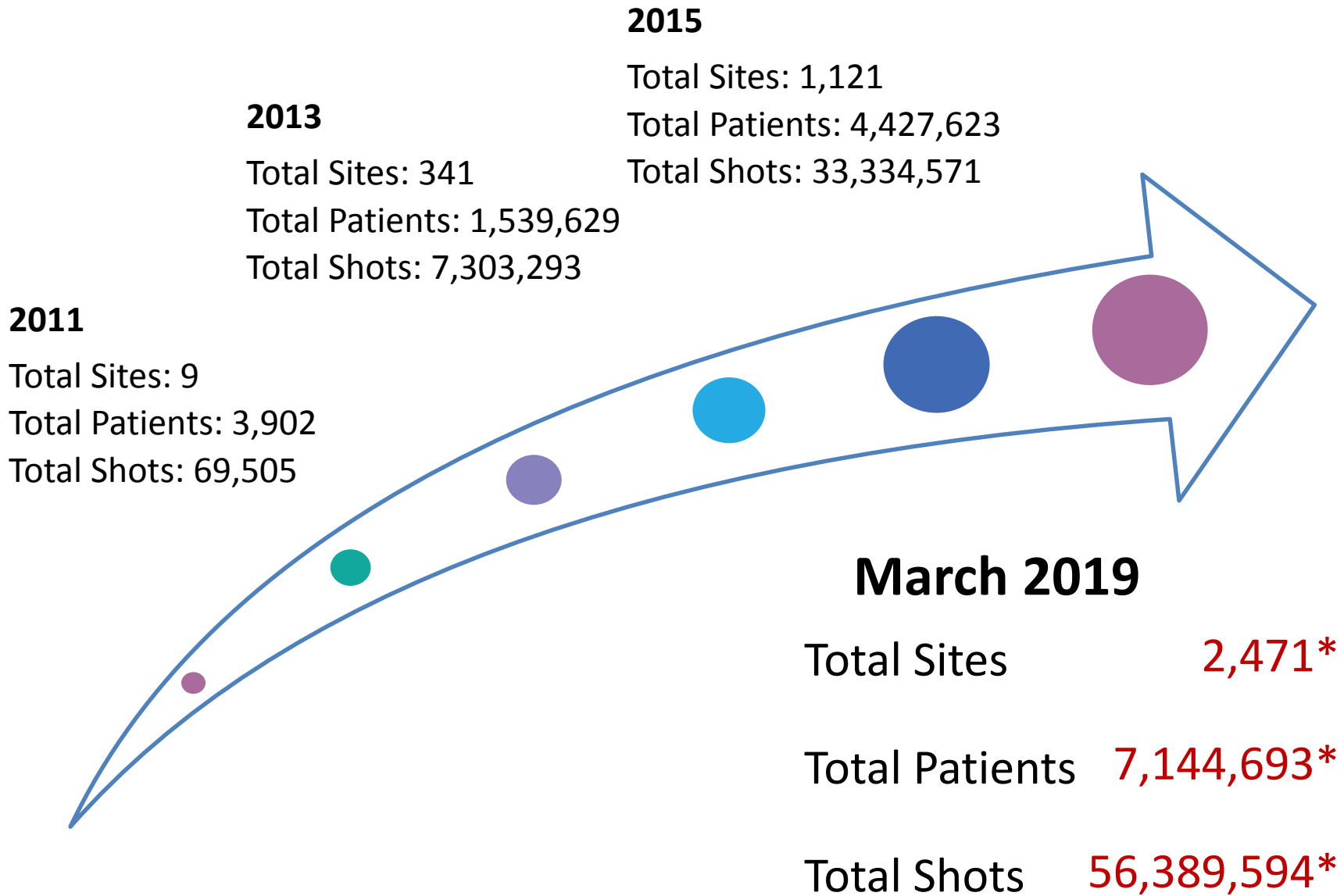

MIIS Overview

- Secure, confidential web-based system capable of **electronic data exchange** and direct data entry
- Consolidates immunization records over lifespan
- Assists providers with clinical decisions
 - Helps identify due or overdue immunizations
 - Prevents over/under immunization
- Includes practice management tools
 - Patient immunization and vaccine usage reports
 - Assists schools with student immunization coverage
- Provides infrastructure for tracking essential information during public health emergencies





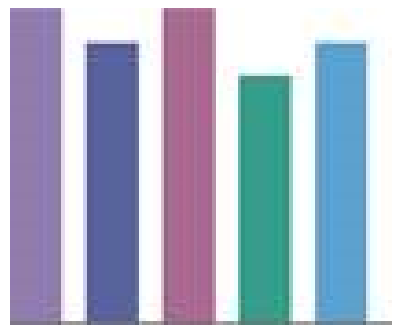

My Site

PROVIDER ENROLLMENT

Before the user can order state-supplied vaccines, the user must first enroll their provider site with the MDPH Immunization/VFC Program. Re-enrollment is required each year.

ADMIN CONSOLE

Admin Console allows the user to view the message summary screen containing HL7 messages as well as other HL7 reports and additional information.

SYSTEM USAGE DASHBOARD

System Usage Dashboard provides a number of statistics about the Practice, Patients and Users associated with the Provider Site.

DATA QUALITY DASHBOARD

Data Quality Dashboard presents and organizes metrics that allow the user to monitor data quality within the application.

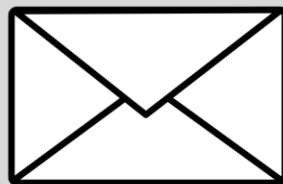

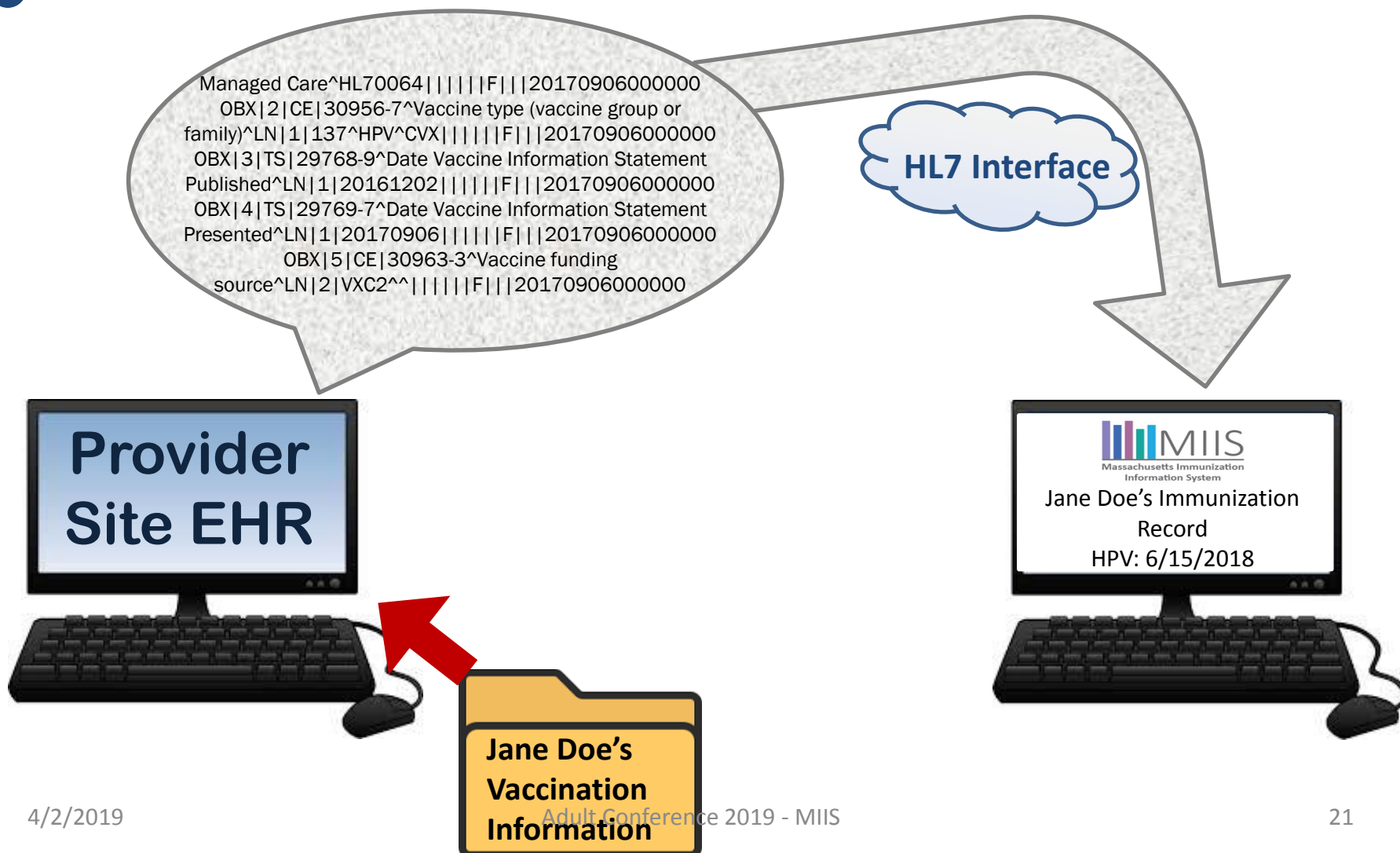
What is HL7?

Health Level Seven (**HL7**) refers to a set of international standards for transfer of clinical and administrative data between software applications

The MIIS receives immunization data from your site through HL7 messages if your site is *LIVE* with **Electronic Data Exchange**
