Welcome and introductions -

Health Equity and Vaccinations in MA – Rodrigo Monterrey, MADPH Office of Health Equity

- Downward trend in the number of flu vaccine received this year, lowest since 2010
- Who is under-immunized, how do we know, and how do we address this?
- Trends: Hispanics and +1 race identifiers have rates higher than overall downward trends, Black non-Hispanic overall upward trend, Hispanic variation overall
- What can providers do? Identify and understand the data, secure funding, facilitate community outreach and education, make vaccines available and accessible (capacity to respond)
- Study the demographics of community (slice the data: look at age, race, ethnicity, language, housing, immigration, employment, health insurance status), meet community members ask questions and listen. Engage and partner with local leaders, including spiritual, health champions, community organizations
- <u>Flu vaccine guide for diverse communities</u> You don't have to do it alone. Partner with people and organizations in your community that already have connections with the group you want to education or vaccinate. You will be more successful, have more fun and build important relationships for the future.
- Plan Do Study Act (PDSA): 2-3 month cycle to see what works, then build on it. Case studies from PDSA are included in the guide.
- Office of Health Equity at DPH Promoting health equity principles and policies across programs, addressing inequities through a system lens. This can inform the way health services are designed, delivered and evaluated.
- Disparities are the difference between populations (ex. rates of heart disease, health outcomes, mortality). Inequities means that the disparities are unjust/preventable. Related to social factors, but no biological reason. Inequities result in disparities.
- How can we work across social and institutional inequities. We need to link data sets, and engage sister agencies to share data
- Health equity is ensuring all people have the opportunity to attain and maintain their full health potential. We must address social determinants of health and uses a social justice framework (inequities), and this is an ongoing process
- Public health is what we, as a society, do collectively to assure the conditions in which all people can be healthy. We call these conditions social determinants of health (violence, built environment, education, employment, housing, social environment). Web-based portal allows input of social determinants of health and be able to address areas based on specific needs.



Conference update - Ted Clark, MDPH Immunization Outreach Coordinator

- 24th Annual MA Adult Immunization conference Finding the Way to Health, April 2, 2019
- 331 attendees, 82% nurses
- Plenary speakers: Dr Kim, CDC, Dr Madoff/Dr Lett Update vaccine/MA, Sarah Wright ACOG, Dr. Choi Reducing health disparities
- Breakout sessions Vaccine Preventable Diseases, MA Immunization Information System (MIIS), Adult Immunization 101, Refugee Health Care on the Continuum
- Overall positive adjustment to new location at the Sheraton Framingham Hotel & Conference Center, some sessions repetitive, need MA update annually
- DPH Updates: Immunization updates 7 in person events 528 participants, Webinars 593 participants

Flu Update - Joyce Cohen, MDPH

- Predominantly InfluenzaA(H1N1), but influenzaA (H3) were more commonly reported since late February, slightly longer season, but not as severe
- By Week 20 (last week in flu season), MA still had widespread flu in comparison to the rest of the US
- CDC burden estimates 37.4-42.9 million flu illnesses reported, 17.3-20.1 million flu medical visits, 531k-647k flu hospitalizations, 36.4k-61.2k flu deaths
- Highest hospitalization rate in 65+ years
- Pediatric flu deaths 4 deaths in MA, 2 children were vaccinated, 2 were not
- ILI (influenza like illness) fever/cough graph (weekly) 322 in 2018-2019 season
- Subtyping characterization: ~65% InfluenzaA, ~14% InfluenzaB (Victoria/Yamagata lineages)
- If patient is negative for flu, test for other viruses such as RSV, RHV/ENT, PIV, HMPV, HCoV, ANENO, Co-infection
- Towards the end of flu season week 18, quieting down of flu across the state. Flu cases do happen throughout the year
- Next year two new vaccine strains included in Flu vaccine: InfluenzaA Brisbane and Kansas
- Can also report on averted deaths vs hospitalizations etc good way to report.
 - Looking at how we counteract, and what are the resonating messages that worked
 - Flu forecasting to extrapolate down to local level to make it more applicable to audience
- 2020 Healthy People goals is a 90% vaccination rate MA still working on upping numbers

Measles Update - Joyce Cohen, MDPH

- Displays as fever and rash starting at the hairline and then moves to extremities
- Measles around the world graph worldwide there are higher rates. Also measles deaths due to lack of care
- As of June 6, 2019, 1022 individual US measles cases, the largest number of cases since 1992, and since measles was declared eliminated in 2000.
 - US measles outbreaks in NY, CA, PA, WA (outbreak is 3 or more cases), the majority were not vaccinated
 - In MA in 2019, 2 confirmed cases of measles both had recent international travel
 - 125 cases investigated, enormous post-exposure effort to identify susceptibles and quarantine/vaccinations. No secondary cases reported due to exposure from these cases
 - MMR vaccine travel recommendations ages over 12months without other evidence of immunity should receive 2 doses, children 6-11months should receive 1 dose

MIIS MMR doses – Kathryn Angher Pier, MDPH

- MIIS Vaccination rates for MMR are pretty consistent in MA, at ~1200 doses/week (in about 76% of VFC sites, reporting to MIIS)
- Higher in younger children noticeable increase in under 1 yrs of age, Feb-Jun
- 2-4 yrs elevated for last few weeks (in June), since the initial report of measles outbreak in US
- 6-12, 12-18, 18-30 yrs there is no noticeable change
- 30-45 yrs increase since April, elevated number receiving vaccine
- 45+ yrs next highest group to get immunized

Immunization reports from the field - Flu update, manufacturer update

- **Sanofi** There is a national shortage of Aplisol, current customers that purchased vaccine direct, allocations will be fine, but still working on wholesale distributor side.
 - Flu return deadline is end of July
- Don Dutra DOD got over the 90% threshold for flu vaccines
- Brittany Rahall Public providers administered an additional 70k vaccines this year
- American Cancer Society (from Korey Hoffman) Current campaign: Mission HPV cancer campaign to increase HPV vaccinations, and to eliminate gender and geographic disparities
