• COVID-19

- Dec 2019 started with pneumonia
- Jan 2020 declared public health emergency
- o Economic toll \$14 trillion
- o 1,131,439 covid deaths, and 6 million+ hospitalizations
- O Vaccines became available in Dec 2020!
 - Orig monovalent 2 dose + booster
 - April 2023 bivalent vaccines currently authorized
 - 2 mRNA vaccines available Moderna, Pfizer, and 1 Protein subunit vaccine -Novavax, J&J no longer available in the US
- O CDC recommends >6mo receive at least 1 bivalent mRNA covid-19 vaccine
- Unvaccinated or previously receiving only monovalent adults Currently recommended
 bivalent mRNA dose
- Over >65, and/or immunocompromised (>12 yrs) can receive additional dose

Respiratory syncytial virus (RSV)

- Annual outbreaks of respiratory illness in all age groups
- o 6,000-10,000 deaths per year due to RSV infection
- o RSV vaccine
 - Development of vaccines which block F glycoprotein from entering cells
 - 2 new RSV vaccines- single dose for adults >60 years old, reduces risk of getting RSV by 85-91%
 - GSK Arexvy
 - Pfizer Abrysvo
 - Indication from FDA for maternal vaccine after 24th week of pregnancy
 - Sanofi Monoclonal antibody against F protein
 - To infants and young children which contributes to passive immunity

Hepatitis B

- o 2.2 million live with it in US
- Transmitted through direct contact with infected blood
- o In US intravenous drug use is most common form of infection
- Previous approach to vaccinating adults was risk based
- April 2022 ACIP recommended expanding indicated range for Hep B vaccination to be
 19-59 yrs to be universally vaccinated, and removes risk based need
- Vaccines available see slides for schedule and options (Recombivax HB, Energix-B, Heplisav-B, Twinrix, PreHevbrio)
 - 3 dose series, does not need to be restarted if schedule is interrupted
- CDC New recommendation 2023 Universal once in lifetime Hep B screening for adults
 >18 years, new screen for each new pregnancy, other risk-based testing

Mpox

- Unprecedented global outbreak in summer 2022, peaked quickly and then waned
- May 2023 cluster of Mpox in Chicago

- o Still ongoing risk for further outbreaks continued vigilance and effort to curb
- Outbreak in US disproportionately affecting MSM, spread through sexual contact, lesions in central areas
- O Vaccine JYNNEOS
 - Live virus vaccine licenses in 2019 for smallpox and Mpox in adults
 - Can be pre or post exposure prophylaxis, intradermally or subcutaneously
 - Vaccine strategy is more effective if receive 2 doses, 4 weeks apart
 - Safe for immunocompromised
 - No general population routine vaccination, more for pre/post exposure or high risk key populations

Pneumococcus

- O Adults Pneumonia, sinusitis, meningitis
- O Invasive pneumo disease young and adult 65+ at most risk
- In 2023 2 new pneumococcal conjugate vaccines were licensed for use in US adults:
 PCV15 (Vaxneuvance, Merck) and PCV20 (Prevnar 20, Pfizer)
- O Vaccine recommendations:
 - PCV polysaccharide attached to a protein PCV15+ PPSV23 pneumovax vaccine one year later, or use one dose PCV20
 - 4 vaccines currently available, 2 Pfizer, 2 Merck
- o Recs 65+ receive PCV
- Consider updating adults that recd PCV13+ PPSV30 rec update to receive PCV20 5 yrs after prior vaccination
- O Can co administer pneumo vaccines with influenza vaccine
- Vaccinator resources

Questions:

Q: Advice for adults that are immunocompromised that are eligible for COVID booster now, would that not make them eligible for the fall vaccine? Amy Squeglia

A: Recommends to get a dose now, need at least a 2 month interval before any other dose. So would still be eligible in the fall as well

Q:Can the pneumococcal vaccine be given at the same time as flu and COVID vaccines? (So all three at once?) Mary Ellen Casey

A: Not a prohibition against doing pneumococcal and COVID vaccine at the same time. Suggest to double check this

Q: With the introduction of the PCV20 vaccine, is there a use case for PCV15/PPSV23 for patients who have not been previously vaccinated? Michele Goulet

A: PCV20 is the most straightforward option, could do PCV15 and a year later PPSV23. One and done is most preferable strategy

GSK RSV Vaccine

John Crowley

- Impact of underlying conditions and RSV
 - Older adults with UC are at risk for severe RSV infection
 - o Peaks in Sept, Autumn
- AREXVY GSK Vaccine for RSV
 - Adjuvanted vaccine for 60+ yrs old
 - o Is indicated for active immunizations for the prevention of lower respiratory tract disease caused by RSV in >60 yo adults
 - Reconstituted vaccine
 - o Intramuscular, do not freeze, refrigerated pre reconstitution

- Manufacturer updates
 - Olga, Moderna WHO Discussion on COVID strain to include in fall vaccine, most likely be XBB1 subvariants of Omicron
 - Kristen Van Epps, Moderna responsible for state procurement for COVID vaccines -Moderna is contracting out with a company that is reaching out to request pre-booking COVID vaccines for the fall
 - John, GSK GSK looking at number of vaccines missed during the pandemic and has partnered with TeleVox working with doctor's office/health departments to send communications (electronic or postcards) to get adults updated on all vaccines, not just GSK vaccines
